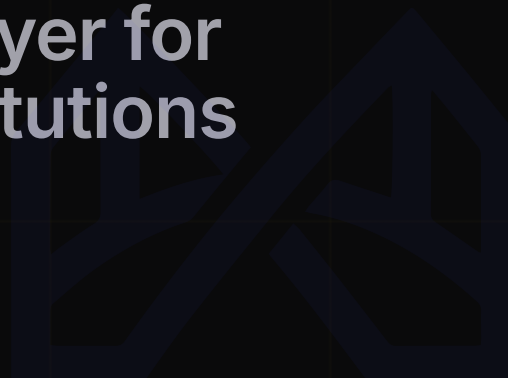

EXECUTIVE SUMMARY

ViaBridge is an institutional operating layer that unifies custody, execution, treasury, and on-chain exposure into a single governed operating surface.

Digital asset infrastructure remains fragmented across custodians, exchanges, prime brokers, and protocols — with governance and treasury workflows enforced outside of execution systems, introducing operational risk and reporting complexity at scale.

THE INFRASTRUCTURE GAP

Institutional digital asset infrastructure evolved in silos — custody, execution, staking, and lending remain operationally disconnected.

Fragmented Custody

- Sub-account sprawl across funds and entities
- No unified real-time balance sheet

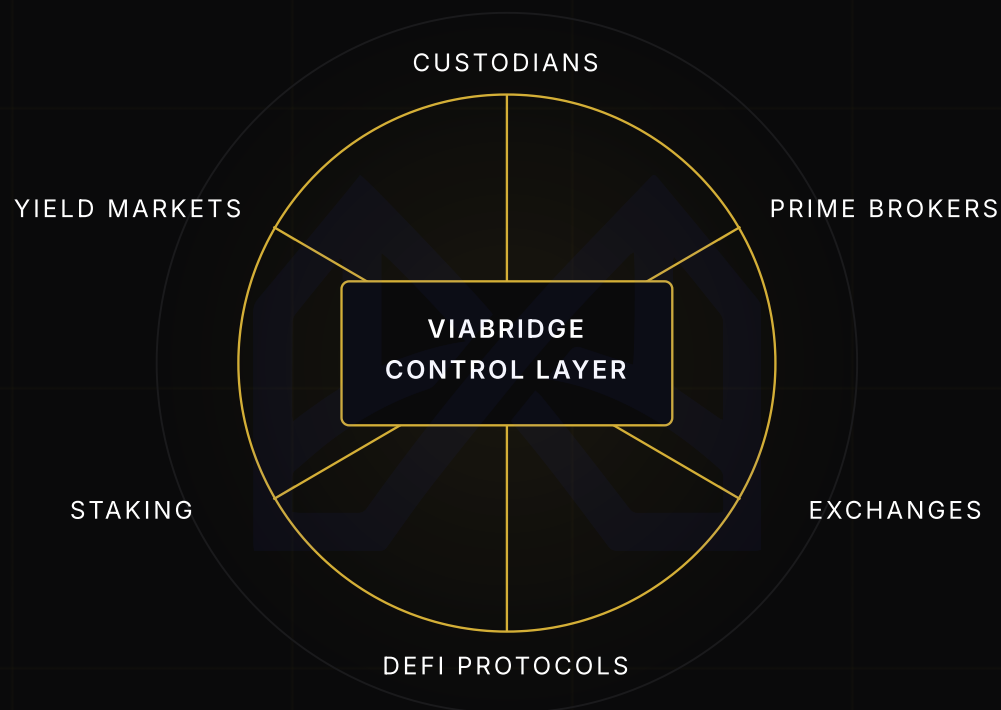
Manual Treasury & Execution

UNIFIED INSTITUTIONAL CONTROL FRAMEWORK



ViaBridge does not replace infrastructure. It orchestrates it.

- Aggregates exposure across counterparties in real time

Aggregated Balance Sheet

Real-time consolidated exposure across custodians, exchanges, wallets, and sub-accounts. Eliminates reconciliation lag and spreadsheet dependency.

Multi-party approval structures, programmable capital allocation, and automated execution routing aligned with institutional policy.

Unified Risk & Reporting

Audit-ready exposure reconstruction, risk monitoring across entities, and consolidated NAV support.

Headless Infrastructure (API)

Complete REST-based API coverage enabling integration with OMS platforms, accounting systems, reporting tools, and proprietary dashboards.
